



It also has an integrated migration functionality to quickly replace legacy storage with new systems without interruption of operation.

By freeing up valuable primary storage space from inactive data, enterprises can delay the purchases of new arrays or additional disks. Less data on primary storage also results in shorter backup times and simplified data management. PoINT Storage Manager allows managers to automate the process of optimal placement of data, resulting in significant savings and enabling new capabilities.



POLICY-BASED TIERING AND ARCHIVING

The policy engine of PoINT Storage Manager supports tiering and archiving of files based on a wide range of criteria and methods. File tiering methods include copying of file (Copy Mode), moving of file (Data Mover Mode) and stubbing of file (HSM Mode).



HYBRID STORAGE INFRASTRUCTURE

PoINT Storage Manager offers integrated support for all storage technologies (disk/flash, object/cloud, tape and optical) including off-line media management for removable media. This gives customers the opportunity to setup a hybrid storage infrastructure and to homogeneously combine on- and off-premise storage. Replacing a storage system is supported by PoINT Storage Manager using the built-in migration functionality. Proprietary hardware solutions with long term dependency and unforeseeable support costs can be avoided and eliminated.

TRANSPARENT MIGRATION

PoINT Storage Manager provides integrated functions for migration of primary and archive storage systems. File systems from older file servers or NAS systems as well as obsolete archive devices can be migrated in background. This concept allows uninterrupted operation of applications and users even during the migration. All data is available during the migration process and no re configuration is necessary.

FILE ARCHIVING

PoINT Storage Manager offers a native WORM file systems as standard Windows CIFS share as well as policy based file archiving from existing primary storage systems. Files are protected against modification or deletion by the sophisticated Archive Volume concept which also includes functions like versioning, authentication and encryption. Archiving requirements can be fulfilled in combination with all types of storage devices which can be configured in the Archive Tier of PoINT Storage Manager.
